UNDERSTANDING THE RISKS

I accept that Canoe Expeditions inherently involves risks and potential hazards. The risks and hazards include but are not limited to impacts with natural and other obstacles such as trees, rocks or other Canoeists, rolling or flipping the Canoe, or being hit by other Canoeists, falling out of the Canoe, and equipment failure. I am aware that participating in multi day Canoe Expedition offered by Canoe Safaris New Zealand can be hazardous if they are not conducted with care, control and responsibility. I acknowledge that these risks could result in my injury (physical or mental) or even death.

Medication/health conditions

- I have informed the staff of Canoe Safaris New Zealand (or will, prior to undertaking the Canoe Safari) of any medical conditions, previous injuries, and any medication I am currently taking which may affect my ability to undertake the activity and I have not been advised otherwise by a qualified medical person.
- I consent to receive any medical treatment that may be deemed necessary by Canoe Safaris New Zealand in the event of injury, accident or illness while undertaking the Canoe Safari.
- I understand it is my responsibility to disclose any conditions (health or otherwise) that may affect the safety and enjoyment of myself and those around me, including but not limited to past injuries, medications taken, diseases or physical or mental disabilities. This can also include obesity and fitness levels and the associated physical restrictions that may apply to undertake a multi day Canoe Expedition.
- I agree to ride with care, and obey the rules set out by Canoe Safaris New Zealand and instructions given by the guide (s) (or a representative of Canoe Safaris New Zealand), at all times.
- I accept that if I do not adhere to the instructions and rules, or if I act dangerously, recklessly or in a way that might endanger myself or others, Canoe Safaris New Zealand may remove me from the activity. If this occurs, I acknowledge I will not only not receive a refund, but will pay any associated costs.
- I accept that Canoe Safaris New Zealand reserves the right to cancel this activity if it becomes concerned for my safety, or the safety of another person.

- I agree to wear appropriate clothing and use/wear all safety clothing and equipment (as required by the guide or company representative), at all times when participating in a Canoe Safari.

Limited liability of Canoe Safaris New Zealand

- I understand that if I act recklessly or intentionally, and don't follow the rules or instructions set out by Canoe Safaris New Zealand and the guide, Canoe Safaris New Zealand will not be held responsible for any injury, damage or loss I cause to myself/my property, or another person/their property, resulting from my action (or lack of action).

Damage to property or equipment

- In the event that I damage any of the clothing or equipment, or other property owned by Canoe Safaris New Zealand, I agree to pay to Canoe Safaris New Zealand all costs associated with repairing the damage.

Drugs/Alcohol
