Bungy Jumping Risk Disclosure

UNDERSTANDING THE RISKS

- I accept that this activity inherently involves risks and potential hazards. The risks and hazards include, but are not limited to whiplash, spinal injury, retinal detachment, ropes/cord becoming wrapped around limbs, bungy cord snapping, and suspension trauma (hanging in a harness for an extended period of time)
- I am aware that participating in the Bungy Jumping activity offered by Sea to Summit Ltd trading as Hanmer Springs Attractions can be hazardous if they are not conducted with care, control and responsibility. I acknowledge that these risks could result in my injury (physical or mental), broken bones, dislocations, lacerations, drowning/secondary drowning, amputation, or even death.
- Not all risks/injuries can be explained as it can be specific to the Bungy Jumper and their own physical health, pre-existing medical conditions, and previous injuries. I understand it is my responsibility to disclose any conditions (health or otherwise) that may affect the safety and enjoyment of myself and those around me.

Refund Policy

- There is a 'No jump, No refund' policy for bungy jumping.
- This cannot be transferred to another person. In the case of a tandem jump if one person pulls out, the other is still permitted to jump
- A **2-minute** time limit is in place for all jumpers. If this time limit is reached, the Jumpmaster will pull back the jumper and no refund to be given.
 - The Jumpmaster will give 2 options - pull back or assisted jump. The Jumpmaster will confirm and requires clear consent for the jumper to be pushed. If no clear consent, the Jumpmaster will pull the jumper back.

Medication/health conditions

- I have informed the staff of Sea to Summit Ltd trading as Hanmer Springs Attractions (or will, prior to undertaking the activity) of any medical conditions, previous injuries and any medication I am currently taking which may affect my ability to undertake the activity.
- I confirm I am physically fit and able to participate in the activities and I have not been advised otherwise by a qualified medical person.
- I consent to receive any medical treatment that may be deemed necessary by Sea to Summit Ltd trading as Hanmer Springs Attractions in the event of injury, accident or illness while undertaking the activities.
- I understand it is my responsibility to disclose any conditions (health or otherwise) that may affect the safety and enjoyment of myself and those around me.

- I understand it is my responsibility to disclose any conditions (health or otherwise) that may affect the safety and enjoyment of myself and those around me.
- I accept that Sea to Summit Ltd trading as Hanmer Springs Attractions reserves the right to cancel this activity if it becomes concerned for my safety, or the safety of another person.
- I agree to wear appropriate clothing and use/wear all safety clothing and equipment (as required by the guide/driver) at all times when participating in the activity.

Limited liability of Sea to Summit Ltd trading as Hanmer Springs Attractions

- I understand that if I act recklessly or intentionally, and don't follow the rules or instructions set out by Sea to Summit Ltd trading as Hanmer Springs Attractions and the staff, which I have been made aware of, Sea to Summit Ltd trading as Hanmer Springs Attractions will not be held responsible for any injury, damage or loss I cause to myself/my property, or another person/their property, resulting from my action (or lack of action).

Liability of landowner

- I agree that the owner(s) of the land on which the activity is conducted will not be held responsible for any death, injury, misadventure, damage to or loss of property caused in whole or part by these activities.

Damage to property or equipment

- In the event that I damage any of the clothing or equipment, or other property owned by Sea to Summit Ltd trading as Hanmer Springs Attractions or a landowner, I agree to pay to Sea to Summit Ltd trading as Hanmer Springs Attractions (or the landowner) all costs associated with repairing the damage.
