



Quad Biking & Off-Road Buggy Disclosure

UNDERSTANDING THE RISKS

- I accept that this activity inherently involves risks and potential hazards. The risks and hazards include, but are not limited to rolling or flipping the Quad Bike or Buggy, hitting obstacles (such as trees, rocks or other riders) or being hit by other riders, falling off the Quad Bike, and equipment failure.
- I am aware that participating in the Quad Biking and Off-Road buggy activity offered by Sea to Summit Ltd trading as Hanmer Springs Attractions can be hazardous if they are not conducted with care, control and responsibility. I acknowledge that these risks could result in my injury (physical or mental), crush injuries, dislocations, broken bones, lacerations, or even death.

Medication/health conditions

- I have informed the staff of by Sea to Summit Ltd trading as Hanmer Springs Attractions (or will, prior to undertaking the activity) of any medical conditions, previous injuries and any medication I am currently taking which may affect my ability to undertake the activity.
- I confirm I am physically fit and able to participate in the activities and I have not been advised otherwise by a qualified medical person.
- I consent to receive any medical treatment that may be deemed necessary by Sea to Summit Ltd trading as Hanmer Springs Attractions in the event of injury, accident or illness while undertaking the activities.
- I understand it is my responsibility to disclose any conditions (health or otherwise) that may affect the safety and enjoyment of myself and those around me.

Conditions of participating in activity

- **I accept that if I do not adhere to the instructions and rules, or if I act dangerously, recklessly or in a way that might endanger myself or others, Sea to Summit Ltd trading as Hanmer Springs Attractions may remove me from the activity. If this occurs, I acknowledge I will not receive a refund and be charged a \$100 vehicle retrieval fee**
- I accept that Sea to Summit Ltd trading as Hanmer Springs Attractions reserves the right to cancel this activity if it becomes concerned for my safety, or the safety of another person.
- I agree to wear appropriate clothing and use/wear all safety clothing and equipment (as required by the guide/driver) at all times when participating in the activity.

Quad Biking & Off- Road Buggy Risk Disclosure

- I agree to provide photo identification upon request that clearly shows my name and date of birth. If I refuse to provide identification, I accept that I will not be allowed to drive/ride any vehicles for the duration of the activity.
- Drivers/riders must be 16 years or older and capable of operating the vehicle safely. Passengers on Off-Road buggy's must be over 6 years old and correctly fit all required safety equipment.

Limited liability of Sea to Summit Ltd trading as Hanmer Springs Attractions

- I understand that if I act recklessly or intentionally, and don't follow the rules or instructions set out by Sea to Summit Ltd trading as Hanmer Springs Attractions and the staff, which I have been made aware of, Sea to Summit Ltd trading as Hanmer Springs Attractions will not be held responsible for any injury, damage or loss I cause to myself/my property, or another person/their property, resulting from my action (or lack of action).

Liability of landowner

- I agree that the owner(s) of the land on which the activity is conducted will not be held responsible for any death, injury, misadventure, damage to or loss of property caused in whole or part by these activities.

Damage to property or equipment

- In the event that I damage any of the clothing or equipment, or other property owned by Sea to Summit Ltd trading as Hanmer Springs Attractions or a landowner, I agree to pay to Sea to Summit Ltd trading as Hanmer Springs Attractions (or the landowner) all costs associated with repairing the damage.
- I accept that any damage sustained to quad bikes and/or buggy's through negligent behaviour will be charged in full to the driver of the quad bike/buggy or to the original bill payer.
- I agree for Sea to Summit Ltd trading as Hanmer Springs Attractions to hold a credit card as security.
- Damage costs are not inclusive to this list. Set fees are: rolling a bike \$300 upwards, colliding a bike with a solid object including another vehicle \$200 upwards, breaking the drive train through misuse \$250 upwards. These costs cover a post incident inspection, labour, and parts to complete any repair work is required. No money will be taken/charged if no damage has occurred

Drugs/Alcohol

- I confirm I am not under the influence of intoxicating alcohol or drugs (be they legal or illegal) which may in any way impair my ability to undertake the activity.

Marketing

- I give Sea to Summit Ltd trading as Hanmer Springs Attractions permission to use all photos and videos of me taken during the activity for promotional and social media purposes.
