RISK DISCLOSURE STATEMENT

Our activities offer unique and memorable experiences. However, like all adventure experiences they carry inherent risks that we, as an experienced operator, want to communicate clearly to all participants. By participating in our experiences, you are voluntarily assuming these risks.

I hereby acknowledge that Wildwire is operated by Our Planet Limited ("OPL") and agree as follows:

- A. **By signing below, I confirm that I have read, understood** the activities offered by OPL, including but not limited to; rock climbing, via ferrata, hiking, abseiling, swimming, rock jumping, bridge crossing ("Activities"); and the travel to, from and within the Activity locations provided by OPL inherently involve risks, which may result in property damage or loss or serious or fatal injury.
- B. That rock fall, cliffs, rivers, drowning, falling, equipment failure, mechanical failure, other non-specified natural circumstances, accident or illness in remote places are an ever-present hazard when taking part in the Activity and travelling to and from and within the Activity locations.
- C. I undertake that I will follow all instructions given by OPL, their guides, employees, contractors and representatives at all times.
- D. I undertake that I have disclosed all relevant medical, physical, and mental conditions prior to signing this declaration and that I am physically fit and have no illness, injury, or condition that may be aggravated by, or affect my ability to safely participate in, the Activity.
- E. I agree to use all safety equipment provided in the manner instructed and required by OPL.
- F. I accept the inherent and increased dangers and risks associated with the Activity and accompanying risk of injury, death or property damage or loss and I hereby assume all inherent risks and dangers associated with the Activity.
- G. I also accept and release OPL and all persons, entities or contractors connected with OPL from all liability for any injuries, damages, property damage, wrongful death, loss of services, loss of profits, consequential, exemplary, indirect or punitive damages or otherwise and from any claim (including legal costs) by me, my family, estate, agents or assigns in any way from my participation in all, and any activities connected with OPL.
- H. I acknowledge that OPL reserves the right to withdraw any person including myself who in their opinion is likely to endanger themselves or others at any time during the Activity.
- I. I acknowledge that OPL reserves the right to cancel the Activity if they become concerned for any reason of my ability or my safety or that of any other person when undertaking the Activity.
- J. I acknowledge that OPL accepts no responsibility for the actions or persons and / or companies supplying services as part of the Activity or any extra costs incurred due to delays or complications beyond OPL's control.
- K. I acknowledge and agree that OPL may take photographs and videos ("Images") during the Activity and use them for marketing and promotional purposes, including on social media, websites, travel brochures, advertising materials, print media, and other promotional channels. I consent to such use without further notice or consent and acknowledge that I am not entitled to any payment, compensation, or acknowledgement in connection with the Images.
- L. I understand that I may opt out of this clause by making my personal Guide aware before commencing the Activity.
- M. If I am not a resident of New Zealand, I will not attempt to avoid this agreement by commencing legal action in another country.
