In signing this documentation consent to receive medical treatment which may be deemed necessary by Waiatoto River Safaris employees in case of injury, accident or illness during your participation in a flight/experience/activity and also agree to indemnify Waiatoto River Safaris in respect of such medical treatment.

The carpark at the boat departure point beside the Waiatoto River is road reserve and is leased by Waiatoto River Safaris Ltd. You understand that parking your vehicle in the carpark is solely at your own risk. You are fully aware that Waiatoto River Safaris Ltd shall not be responsible for any damage to, injury resulting from, or theft of your vehicle, equipment or any personal belongings left in the vehicle or equipment while parked in the carpark, and you indemnify Waiatoto River Safaris Ltd against such claims.
